⇒ **Attention: CAP-MR/DD Providers and I/DD TCM Case Managers.**

Extension of current CAP-MR/DD waiver and process for submitting authorization requests

The Division of Medical Assistance (DMA) has asked the Centers for Medicare and Medicaid (CMS) for another extension for the current 2008 CAP MR/DD waiver. The extension was requested because DMA and DMHDDSAS are working with CMS to review NC's progress on our 2008 CAP MR/DD waiver transition plan for recipients residing in facilities with more than 16 beds and the Divisions are addressing final questions about transition to the new waiver requirements.

When the waiver is approved by CMS, DMA will publish the final services with the effective start date of the waiver. The proposed implementation date for the renewal CAP I/DD waivers may be up to 90 days. Details of this extension will be communicated in the January 2012 Implementation Update.

⇒ **PROVIDER SELF-AUDIT:** The North Carolina Division of Medical Assistance (NCDMA) – Program Integrity (PI) section relies upon the health care industry to assist in the identification and resolution of matters that adversely affect the Medical Assistance Program, and believes that a cooperative effort in this area will serve our common interest of protecting the financial integrity of the Medicaid Program and ensuring proper payments to providers. NCDMA encourages Medicaid providers to implement necessary policies, processes, and procedures to ensure compliance with federal and state laws, regulations, and policies relating to the Medicaid Program. As part of these policies and procedures, DMA recommends that providers conduct periodic audits to identify instances where services reimbursed by the Medicaid Program are not in compliance with Program requirements.

Over the years, NCDMA has encouraged all provider types to voluntarily come forward and disclose any overpayments or improper payments (herein referred to as inappropriate payments) of Medicaid funds. Upon review of recent disclosures and supporting audits, NCDMA has become concerned about the lack of uniformity of audits submitted for purposes of self disclosure.

In light of these concerns, NCDMA decided to establish a protocol for self audits by Medicaid providers that participate in the fee-for-service environment. While providers have a legal duty to promptly return inappropriate payments that they have received from the Medicaid Program, use of the protocol is voluntary. The protocol simply provides guidance to providers on the preferred methodology to return inappropriate payments to NCDMA. This voluntary protocol does not in any way affect the requirements of the Single Audit Act or other independent audit requirements.

In establishing this protocol, NCDMA recognizes that it must continue to encourage Medicaid providers to conduct self audits and to provide viable opportunities for disclosure. Toward that end, NCDMA renews its commitment to promote an environment of openness and cooperation. The flexibility built into this protocol reflects both our desire to encourage voluntary disclosure and our commitment to openness and cooperation.

NCDMA's Self-Audit Protocol is intended to facilitate the resolution of matters that, in the provider's reasonable assessment, potentially violate state administrative law, regulation, or policy governing the Medicaid Program, or matters exclusively involving overpayments or errors that do not suggest violations of law. It is possible that the Division may, upon review of information submitted by the provider or upon further investigation, determine that the matter implicates state criminal or federal law. In such instances, the Division will refer the matter to the appropriate federal or state agency.

- ⇒ **Changes in IPRS Rules Regarding Target Populations-** DMH/DD/SAS has implemented new rules retroactive to 7/1/11 related to the assignment of target populations. Previously, consumers could only be in one target population at a time even if they had multiple disabilities. For instance, a consumer could have both a mental health disorder and a substance abuse disorder, but could only be in one target population (either mental health or substance abuse) to pay for services in both disabilities. The Division has now modified the rules related to target populations so that consumers can be in more than one target population concurrently. For the most part, they can only have one target population within each disability area, i.e., an adult with substance abuse issues can have only one adult substance abuse target population. However, if that individual has mental health issues as well, that person can have both a mental health and a substance abuse target population.

A copy of the IPRS Concurrency Table is provided as an attachment to provide documentation of which target populations can be assigned to a person simultaneously. The first sheet of the [Concurrency Table](#) provides instructions for the selection of multiple target populations.

Providers who have eCura Provider Connect licenses will continue to use the Target Pop Update. There have been some slight modifications to allow the entry of a diagnosis specific to each disability. - ⇒ **Due to state budget reductions to the LME, Adult Flex Funds are no longer available for individuals needing this assistance.**
- ⇒ **MeckPROMISE** has developed a comprehensive employment curriculum, "You're HIRED!" based on the Choose, Get, Keep Model through Boston University Center for Psychiatric Rehabilitation. This is a 12 week, twice weekly course for people in mental health recovery who are very serious about employment. Courses will begin in January; each class will be limited to 6 students and the cost is \$20 per person and includes all materials.
