#### **MEETING CALLED TO ORDER AT 9:12 AM**

### **Welcome and Announcements**

Michelle Lancaster (County Manager's Office) opened the meeting and deferred to The Honorable Judge Richard Boner (Superior Court) who announced that a seminar would be held November 18 in Room 267 of the government center to discuss the Court's expectations for professional behavior in the criminal court rooms. Attorneys from the District Attorney's office, Public Defender, and those on the court–appointed list have been invited. The event will be recorded for distribution to those unable to attend.

### **Case Management**

Todd Nuccio (Trial Court Administrator) reviewed with members the findings of the recently completed Drug track case management analysis and compared the outcomes of that with those observed in the Persons and Property tracks. Nuccio noted average case load age had been reduced significantly with the introduction of the 2008 Case Management Plan. Drug case processing, however, is notably slower than Persons and Property. Nuccio suggested the slower times may be the result of the comparatively larger volume of cases and delays resulting from a Supreme Court ruling which requires the lab technician who performed the analysis to be the same person that testifies in court.

## **Democratic National Convention Update**

Deputy Chief Harold Medlock (CMPD) recognized and thanked members for their participation and effort in the planning process thus far. Opening comments were followed by a discussion regarding the availability of officers for court during the week of the convention. The manpower required to provide event security will prohibit officers from participating in regular court functions; case scheduling and preparation must take this account. In addition, Medlock generally discussed public access to court facilities during the event and prisoner processing in mass arrest situations.

## Mecklenburg County Justice Reinvestment Initiative

Richard Stroker (Center for Effective Public Policy) provided a brief update on project progress and next steps, reminding members the goal was to more objectively understand the criminal justice process. The sub-committee process was reviewed; including topic areas, membership, and tentative time lines. Each committee will identify and present to the greater CJAG membership 3 issues which warrant increased exploration. The CJAG will, through consensus, then identify the top ten issues which to further analyze as a part of the JRI.

Michelle Lancaster informed members Criminal Justice Services staff will facilitate the focus group meetings.

Members were presented a copy of the Criminal Justice System Process Map and Tom Eberly (Criminal Justice Services) explained its utility in identifying and planning for change within the system.
