
various locations throughout the month. The booklets contain stories and encouraging sentiments from past and present DTC clients, team members and partners.

#### **Bridges Out of Poverty**

On Friday, April 8, Drug Treatment Court hosted a training session entitled Bridges out of Poverty. This curriculum provides professionals who work directly with those in poverty a better understanding of the challenges and strengths of their clients without judging. Participants explored ways of using Bridges out of Poverty within the criminal justice system, as we encourage the promotion of equal justice under the law for all persons regardless of economic status. The challenge is to identify obstacles within the criminal justice system for those from generational poverty. Once identified, efforts are made to eliminate them without jeopardizing the integrity of the criminal justice system. Attendees received a copy of the book *Bridges Out of Poverty*, which was included in the cost of registration.



### **Chinese Officials Visit Mecklenburg Courts**



The guests began their visit by taking a tour of the Mecklenburg County Courthouse. In the evening, they attended a dinner and reception hosted by The Charlotte School of Law. On Wednesday, Chief District Court Judge Lisa C. Bell welcomed the visitors. Afterwards, they were given an introduction to Drug Treatment Courts. In the afternoon, the group took a tour of Jail North before coming back to the courthouse for a panel discussion with District Attorney Andrew Murray, Public Defender Kevin Tully, Assistant Public Defender Bob Ward, District Court Judge Elizabeth Trosch, and David Wallace with the National Association of Drug Court Professionals.

The visit was made possible through a partnership with the UNCC Criminal Justice Department, The Charlotte School of Law, and the Mecklenburg County Drug Treatment Courts.

#### District 26 Wins Award for Judicial Administration

The North Carolina Conference of Court Administrators (NCCCA) recently announced the 26<sup>th</sup> Judicial District of North Carolina (Mecklenburg County) as the winner of the 2010 Judicial Administration Award. The Judicial Administration Award was established by the NCCCA to publicly recognize courts and related organizations in the State of North Carolina for meritorious projects and exemplary accomplishments that enhance the administration of justice. A plaque was awarded and will be displayed in the Trial Court Administrator's Office in the Mecklenburg County Courthouse. The 26<sup>th</sup> Judicial District was selected this year for the innovative creation of Justice Initiatives, Inc., a local non-profit.

The Trial Court Administrator's Office recently hosted several visitors from abroad through a partnership with International House. A delegation of three government and human rights officials from Bangladesh, Kazakhstan, and Tajikistan were in Charlotte April 7 through May 1 for a professional exchange program through the Legislative Fellows Program, a U.S. State Department Program, in collaboration with International House in Charlotte.

The Legislative Fellow Program is designed so participants can engage in meetings related to legislation, the role of civic society, and the relation between communities and local government. These particular participants were interested in observing legislation in action, attending meetings with local judges and/or court officials, gaining a better understanding of the role of government, the electoral process, and how legislation affects communities.

The participants included Ms. Fahima Quoreshi from Dhaka, Bangladesh. She is the vice president of Dhaka University, Joint Secretary of Gulshan Society, Executive Member of Bangladesh National Women

Lawyers' Association, among others. She is currently involved in human rights as an activist and also filing public interest litigation for women and children's rights. Mr. Oleg Nikolaevich is currently the Deputy Head at the Department of International Policy of Almaty City in Kazakhstan. He is interested in the role of local government in civil society. He implements policies to promote unity between communities and local government. He also implements democratic principles of social harmony and political stability, foster civic patriotism, development of a common strategy and coordinated interaction of all structures of local executive authority in the field of public relations, social sphere, science, education, culture, health, media, youth, language policy, tourism, and sport. Ms. Dilorom Saidjonovna hails from Khujan, Tajikistan. She is a Local Government Specialists, Member of Mercy Corps and Brandy Westerman. She is interested in strengthening the link between communities and local government, and the role of civil society and politics along with immigration issues.

The delegates visited the Mecklenburg County Courthouse on Friday, April 15 and were given a tour of the building. After the tour, they met with Trial Court Administrator Todd Nuccio who gave them a presentation on the structure of North Carolina court system, as well as information as to how legislation is created in North Carolina. The delegates enjoyed their visit and indicated that they learned a great deal. The information they received can be used to further their efforts in their respective countries once they return.

## Long Awaited Juror Website Goes Live

Residents summoned for jury service in Mecklenburg County courts can now access detailed information about their jury service and submit requests to the Jury Management Office online with a new interactive application created by the Mecklenburg County Information Services & Technology (IST) Department, in conjunction with the Trial Court Administrator's (TCA) Office, called the Jury Manager System.

Residents who receive a summons for jury service can access and manage their information online at jury.mecklenburgcountync.gov, as an alternative to contacting the TCA's Jury Management Office by phone or mail. The Jury Management Office is staffed by only two Jury Coordinators (one full-time and one part-time) who are responsible for issuing approximately 6,000 summonses per month and performing all jury management functions, which includes responding to a high volume of requests and inquiries pertaining to jury service. The TCA's Office sought assistance from IST with developing an interactive online jury management application that would reduce staff time involved with answering calls and processing mail, decrease the cost of communicating with jurors by mail when a request to be deferred or excused is submitted, improve response time (jurors are notified automatically by email when their request has been processed) and the overall level of customer service provided to jurors, thereby increasing customer satisfaction.

Most interaction between residents who receive a summons to appear for jury service and the Jury Management Office involves requests for deferral of jury service, excusal from jury service, and summons information, when lost or misplaced. The new application was designed to manage these common requests and offers many helpful features for jurors, including the ability to look up a lost juror number and obtain reporting instructions; view current reporting status or the status of a request for deferral or excusal submitted via the online application; access jury service history; verify or update personal data; request a deferral or an excusal; request special assistance; learn about the "no pay" option; request a jury service reminder; view and contribute to the "Employer Honor Roll," for employers who continue to pay jurors while they serve; complete a pretrial questionnaire or an exit questionnaire; print jury service notifications; and print an employer letter, verifying service dates and the amount to be paid; or a jury service verification certificate after service has

been completed. Since the online application went live on April 1, 2011, in excess of 1,500 requests for deferral and excusal have been submitted and processed via the website.

IST created the application in-house at no additional cost to taxpayers. It is estimated that the internal labor cost for the project was \$95,000. The TCA's Office anticipates the application will significantly reduce its costs and the staff time required to process mail and answer calls, which will enable the Jury Coordinators to be more attentive to those who report for jury service.



## Girl Scouts Learn About Careers in the Court System

A group of local Girl Scouts from the Hornet's Nest Troop recently spent a portion of their spring break learning about the North Carolina court system and the various career tracks associated with it. This educational program was made possible through a partnership with the Girl Scouts of America, the 26th Judicial District Trial Court Administrator's Office, the Mecklenburg County Sheriff's Office, The Charlotte School of Law, and Moore & Van Allen. Superior Court Judge Hugh B. Lewis spearheaded the initiative. The program took place over two days and included lectures and hands-on activities. The par-

ticipants ranged in age from fourteen to eighteen.

On Saturday, April 16, the group of Girl Scouts visited Moore & Van Allen in their law offices located in the Bank of America building in uptown Charlotte. A variety of speakers talked to the girls about various careers available to them, including administrative positions within the court, Guardian Ad Litem, crime scene forensics, in addition to being a lawyer and a paralegal.

On Tuesday, April 19th, the group visited the Mecklenburg County Courthouse where they had lunch in the Judges' Conference Room before breaking up into groups to observe actual trials. Volunteers from The

Charlotte School of Law and other volunteer attorneys and paralegals assisted the girls as they made their way from courtroom to courtroom. After court, Deputy Sheriffs Robert Sherwin and Linda Lopez gave the girls a presentation on the Mecklenburg County Sheriff's Office K-9 Unit, which included a demonstration of a bomb-sniffing and a search and rescue K-9. Afterwards, the girls enjoyed a pizza dinner before breaking up into groups to conduct a mock trial in actual courtrooms. The program ended around 8:30 in the evening.

This was the first in what could be a regular program to educate Girl Scouts about the North Carolina court system, as well as the various career path girls might choose as they mature.

#### Committee to Focus on State Employee Wellness

In an effort to help staff meet new health insurance requirements, the 26th Judicial District has formed a wellness committee to explore and implement wellness options for state employees. The committee is made up of volunteer representatives from various court agencies, including the Trial Court Administrator's Office, Clerk of Superior Court's Office, District Attorney's Office, and the Public Defender's Office. The group has met several times to examine materials provided by the Administrative Office of Courts, as well as begin to map out a plan to identify, promote and implement wellness opportunities and services. A



survey will be conducted among all state employees to determine what types of services are already in place, as well as to determine the types of opportunities and services employees might be interested in. Once the survey has been completed and the data compiled, the committee will move forward with efforts to establish wellness opportunities. The group envisions a range of services that could be available to state employees including opportunities for exercise during the workday, nutritional training and information, establishing more options for healthy eating in the work place, stress management, and smoking cessation classes.

To promote the idea of wellness, several state employees recently participated in an Eat Smart, Move More, Weigh Less class offered through Mecklenburg County. The fifteen week course consisted of weekly classes and weigh-in sessions. Participants monitored their weight loss each week while learning about healthy nutrition and exercise techniques. At the end of the course, participants lost a total of 130.5 pounds. This means each person lost 4% of their total body weight. The two biggest losers lost 33.5 pounds and 19 pounds!

More information will become available as the Wellness Committee continues to meet and explore ideas.
