COMMISSIONER'S COURT  
FEBRUARY 25, 2010

The Gaston County Board of Commissioners (BOC) met in Regular Session on February 25, 2010 at 6:00 pm in the Commissioners Room, Gaston County Courthouse.

Chairman Mickey Price presided with Commissioners Allen R. Fraley, Vice-Chair; Joe D. Carpenter, Tom Keigher, Donnie Loftis, Tracy L. Philbeck and John A. Torbett in attendance.

Others present included Jan Winters, County Manager; Charles L. Moore, County Attorney; and Martha M. Jordan, Clerk to the Board.

Upon request of Chairman Price, Commissioner Carpenter led those assembled in the Invocation and Commissioner Torbett led in the Pledge of Allegiance.

Announcement by the County Attorney

The County Attorney announced that last meeting a public hearing was scheduled for financing on the Energy Park Project at the Landfill; work is continuing on the financing necessitating rescheduling the public hearing to the March 25, 2010 meeting.

Chairman Price announced the Public Hearing as advertised; explained procedures to be used; called for the motion to enter into Public Hearing.

On motion introduced by Commissioner Torbett and seconded by Commissioner Loftis, the BOC unanimously entered into Public Hearing.

Ms. Sara Carpenter, GIS Specialist, advised of receipt of a petition containing two of the three property owners signatures; the private drive is located inside the Stanley jurisdiction; cabin structure is not visible from the highway; road naming will not impact other owners or businesses; Planning Board voted unanimously to support the naming at its January 28 meeting; a phone call for general information was received from a third property owner who then submitted an e-mail supporting the naming of El Remarko Drive.

On motion introduced by Commissioner Torbett and seconded by Commissioner Philbeck, the BOC unanimously approved the naming of El Remarko Drive.

Ms. Carpenter advised that the property owners had petitioned to change Mauney Place to Mauney Place Road due to a duplicate road name; property owners were notified on 1/15/2010; petition was received on 2/1 with 100% of the property owner signatures supporting the name change; this action supports the 911 request.

Chairman Price called for a motion to close the Public Hearing.

On motion introduced by Commissioner Torbett and seconded by Commissioner Loftis, the BOC unanimously approved the Agenda of February 25, 2010 with changes as noted above.

### Citizen Recognition

Dr. William Shannon, 150 Stowe Dairy Road, spoke regarding exemptions in the property tax for not-for-profit organizations; indicated a \$1.1M exemption for Gaston Memorial Hospital (GMH) per recent newspaper article; related that GMH staff members must sign an agreement not to say anything against GMH; explained that GMH has a large volume of assets and land holding; competes with the private sector via various GMH subsidiaries; patients are referred from GMH to GMH subsidiaries; private practices have been purchased by GMH; cited delays in surgical schedules; \$1M in bonuses and salaries paid to an administrator last year; questioned the mission of a non-profit facility.

Chairman Price stated that the new GMH CEO had requested individual meetings with commissioners; assured the issue would be brought forth; clarified that the issue would be to look at the non-profit status of an organization having businesses that compete with the private sector that pay no taxes.

The County Manager advised that Tax Department was looking at non-profits county-wide.

Mr. Bill Starnes, Mount Holly, spoke in favor of the *Legislative Request to Use Electronic Message Boards to Alert Motorists to be More Acutely Aware of the Dangers of the Motorcyclists and to "Look Twice and Save a Life"*; indicated that the electronic signs would need to be programmed; no additional funding required; trying to heighten awareness since 2/3 of accidents involve a four wheel driver.

Mr. Michael Lee, Public Works Department, spoke regarding the Windsong Forest Subdivision Road Assessment Petition heard at the January 28 meeting, the engineering cost estimate had been received and shared with the petitioners; the residents withdrew the petition due to the cost. He

indicated there were fourteen other roads in the County in basically the same situation.

Debate ensued as to how to proceed including speaking with NC-DOT, contractors, various payment methods, afford ability, etc., and Chairman Price instructed staff to keep the item on the "to do" list and to pursue term adjustments, etc.

The County Manager assured that GEMS could access the homes with all terrain vehicles and were aware of the road conditions.
