Judge William Gaston Award Presentations

Chairman Price presented:

- · A very important part of this Board's mission is to encourage citizen participation in county government and community involvement
- In 1998, the County Commission established an annual award bearing the name of the county's namesake, Judge William Gaston (1778-1844), to recognize those volunteers who have demonstrated exemplary commitment, dedication, and leadership. Since its establishment, the County Commission has honored 35 recipient volunteers for their services to the Gaston County community
- Tonight, the Board of Commissioners has the privilege of recognizing four outstanding individuals as William Gaston Award Winners:
 Mr. J. Phil Coyle, Mr. David Allen Smith, Mr. William "Bill" Craig
- Mr. W. Alex Hall who will not be in attendance this evening due to a scheduling conflict. We will recognize him at our January 27, 2011 Regular BOC Meeting
- At this time, I would ask Mr. Coyle to come to the podium along with any family and friends he has with him to receive the first William Gaston Award for 2010
- Commissioner Carpenter will be making the first presentation.

Mr. J. Phil Coyle

Commissioner Carpenter presented:

- . Mr. J. Phil Coyle would you please join me at the podium and have Dottie, your children, and friends to come forward with you
- Phil Coyle began his initial volunteer service with the Gaston County Planning Board in January 2003 and has become very active and knowledgeable in advancing the organized growth and land use of the County that he loves
- Phil also currently serves on the Economic Development Commission which is a County appointed board that oversees the recruitment
 of new businesses and the preparation of industrial parks to facilitate industrial/commercial growth in order to supply good paying jobs
 for the people of our County. As a matter of fact, when the demise of the former Gaston Industrial Development Corporation occurred,
 it was Phil Coyle who approached the County Commission and lobbied to continue the economic development function as an arm of the
 Chamber by forming a joint operating/funding partnership under the Chamber's umbrella
- In December 1996, Phil's political aspirations led him to run and be elected to a seat on the Gaston County Board of Commissioners. His
 leadership abilities served him well as Commission Chairman in 1999 and Vice-Chairman in the latter part of 2000
- Phil has been a very instrumental member of our community serving not only as a volunteer and a former elected official, but he also served as Gaston County Chamber of Commerce CEO for sixteen years, was elected President of the North Carolina Association of Chamber Executives, and was twice named "Chamber Executive of the Year." Mr. William "Bill" Craig

Commissioner Keigher presented:

- Mr. Bill Craig would you please join me at the podium along with Wilma, and any others who would like to come and stand in your support
- In January 1989, Bill became one of the founding members of the Quality of Natural Resources Commission which was recognized as a model throughout the State of North Carolina. Bill's volunteer service with the Gaston County Planning Board started on January 10, 1991 and his participation on the Firemen's Relief Fund Board of Trustees started in December 1993. To this day, he has continuously served on each of these three County Commission appointed boards. As you can see, Bill just does not stop giving and giving and giving! His dedication and contributions in land use matters, land preservation, land resources, and environmental protection is immeasurable. Known for his versatility in contributing thoughtful ideas and his energy in seeking common goals of the organizations that he serves, Bill is a team player who does not seek personal recognition, although he has received numerous awards for his work
- In 1976, Bill was elected to serve on the Gaston Soil and Water Conservation District Board, another position that he has held continuously since that year. This Board along with the QNRC established and maintains the GIS System that provides up-to-date information to evaluate natural resource concerns, and aids in land use planning so vital to the maintenance of our natural resources. He endeavors to educate people that open land is not vacant land, but a valuable resource to the entire community
- He has been a lifelong farmer, active in establishing Voluntary and Enhanced Agriculture Districts and the Farmland Protection Ordinance. Bill has served on the NC Farm Bureau State Board of Directors, was an adviser to the NC State College of Agriculture and Life Sciences, and was chairman of the 1976 Bicentennial Commission that spearheaded the opening of the Gaston County Art & History Museum on July 4, 1976
- In his immediate community, Bill has served as a Mason for fifty years, a volunteer fireman for 27 years, and was instrumental in the formation of the Union Road Library. He is an active member of Union Presbyterian Church, the NC Presbyterian Historical Society, and likes to dabble in the heritage of his kin folks
- His integrity, vision, and leadership are evident in all that he undertakes, and I think we can safely say that Bill is a "no quitter"
- Bill, you have generously given of your time and expertise in making Gaston County a better place to live for current and future residents, and we are indebted to you for your volunteer service

Presentation of Commendation/Award to Commissioner John A. Torbett

Chairman Price called Commissioner Torbett and wife, Viddia, to the podium and presented the following:

WHEREAS, the Citizens of Gaston County elected John A. Torbett to the Gaston County Board of Commissioners in September 2002 and in November 2006 as a representative from the Riverbend Township, and Commissioner Torbett received the Oaths of Office on December 2, 2002 and December 4, 2006; and,

WHEREAS, in his official capacity, Commissioner Torbett served on the following:

Centralina Council of Governments - 2002 - 2010 Charlotte Regional Partnership - 2005 - 2010 Criminal Justice Partnership Act Advisory Board - 2002 - 2010 Emergency Medical Services Committee - 2003 - 2010 Fire Advisory Board - 2004 - 2010 Juvenile Crime Prevention Council - 2002 - 2005; 2008 - 2010 Lake Norman RPO - 2004 - 2010 NC Association of County Commissioners - 2002 - 2010 Water/Sewer District Board - 2002 - 2010 Quality of Natural Resources Commission - 2003 - 2006 Regional Greenway Network Committee - 2003 - 2006 Gaston County Schools Facility Committee - 2005 - 2006

WHEREAS, Commissioner Torbett's main thrust was to minimize the financial impact of county government on its Citizens while protecting and providing a stable system to respond to their needs. He adamantly supported aligning County finances in order to live within means and to prepare for future growth. To this end, he introduced resolutions for efficient budgeting and ten directional points in order for staff to accomplish a trend of examining, evaluating, and implementing new policies resulting in tax rate reductions proving more fitting for current economic times. Thus, no property tax rate increase was imposed during the past eight years due to the County Commission's fiscal accountability which, by Gaston County Historical Records, is the longest period of time without a tax rate increase; and,

WHEREAS, to ensure that Gaston students were well prepared to become leaders of tomorrow, Commissioner Torbett supported Gaston County School construction projects, funding for band equipment and uniforms, and initiated an incentive loan program for school Booster Clubs. He served as an advocate for the Gaston Regional Science and Engineering Awards, the Entrepreneurial Student Contest for Business Ideas, and the Commissioners School of Excellence. Commissioner Torbett also sponsored the \$27.5M Bond Issue resolution for Gaston College; and,

WHEREAS, Commissioner Torbett sponsored and rallied support for adoption of the following: Several water/sewer projects, reactivation of the Piedmont & Northern Railway between Gastonia and Charlotte for job enhancement and economic opportunities, equipment for volunteer and paid firemen, improved response time of emergency medical services, the police lake patrol, gang intervention, illegal immigrant policies, a public safety driving track at Gaston College, and enhancement of Economic Development Investment Grants to promote job growth; and,

WHEREAS, honoring Gaston County Veterans and active military personnel, Commissioner Torbett developed the "Shield of Honor" to be bestowed on military units having served the United States of America in Iraq, Afghanistan, and future theaters of operation.

NOW, THEREFORE, BE IT RESOLVED that the Gaston County Board of Commissioners, on behalf of the Citizens of Gaston County, commends and extends its grateful appreciation to

John A. Torbett

for his eight years of dedicated service to the people of Gaston County, and encourages him to continue to exercise his knowledge, skills, and talents to effectively and efficiently address the people's issues in the effort to minimize the financial impact of government while providing for the safety and security of its Citizens while serving in the North Carolina House of Representatives.

BE IT FURTHER RESOLVED that this Commendation, as adopted this 18th day of November 2010, be made a part of the Minutes of this County Commission.
