The Gaston County Board of Commissioners (BOC) met on December 6, 2010 following the Swearing In Ceremony in the Commissioners Room, Gaston County Courthouse, for the purpose of reorganization of the County Commission.

Commissioners Joe D. Carpenter, Allen R. Fraley, Tom Keigher, Donnie Loftis, Tracy L. Philbeck, and Mickey Price were in attendance and welcomed new County Commissioner Chad Brown to the BOC.

Others present included Jan Winters, County Manager; Charles L. Moore, County Attorney; and Martha M. Jordan, Clerk to the Board.

#### **Election of the Chairman**

The County Attorney entertained nominations for the Chair of the Board as follows:

Commissioner Fraley nominated Commissioner Donnie Loftis to serve as Chair of the Gaston County Board of Commissioners and Commissioner Brown provided the second.

The County Attorney called for any further nominations and with none being heard declared the nominations closed. He then called for the vote to elect Commissioner Donnie Loftis as Chairman of the County Commission and the motion carried unanimously as follows:

2010-357 Commissioner Donnie Loftis is hereby elected to serve as Chairman of the Gaston County Board of Commissioners.

## **Election of the Vice-Chairman**

Chairman Loftis entertained nominations for the Vice-Chairman of the County Commission.

Commissioner Brown nominated Commissioner Tracy L. Philbeck to serve as Vice-Chairman of the County Commission and Commissioner Price provided the second.

With no further nominations being heard, Chairman Loftis declared the nominations closed.

### **Resolution of Meetings with Legislative Delegation**

- BE IT FURTHER RESOLVED that the time and place of the aforementioned meetings are to be scheduled by the Chair after consultation with the members of the legislative delegation.

#### **Resolution for Organizational Planning Session**

On motion introduced by Commissioner Philbeck and seconded by Commissioner Price, the BOC unanimously approved Resolution **2010-365** as follows:

NOW, THEREFORE, BE IT RESOLVED by the Gaston County Board of Commissioners that the policy of the Board of Commissioners shall be to have one major annual Planning Session in January with said date and location being determined at a later time.

Commissioner Price encouraged all to submit discussion items to the Clerk to the Board as soon as possible in order to obtain background information and schedule participants regarding the issue.

#### **Other Matters**

Chairman Loftis thanked fellow commissioners for his election as Chairman and welcomed comments from the other commissioners.
