The Gaston County Board of Commissioners (BOC) met in Regular Session on January 27, 2011 at 7:30 pm, immediately following the Rescheduled Work Session, in the Commissioners Room, Gaston County Courthouse.

Chairman Donnie Loftis presided with Commissioners Tracy L. Philbeck, Vice-Chair; Chad Brown, Joe D. Carpenter, Tom Keigher and Mickey Price in attendance.

Others present included Jan Winters, County Manager; Charles L. Moore, County Attorney; and Martha M. Jordan, Clerk to the Board.

Upon request of Chairman Loftis, Commissioner Philbeck led those assembled in the Invocation and Commissioner Price led in the Pledge of Allegiance.

### Judge William Gaston Award Presentation

#### Chairman Loftis presented:

- · A very important part of this Board's mission is to encourage citizen participation in county government and community involvement
- In 1998, the County Commission established an annual award bearing the name of the county's namesake, Judge William Gaston (1778-1844), to recognize those volunteers who have demonstrated exemplary commitment, dedication, and leadership. Since its establishment, the County Commission has honored 38 recipient volunteers for their services to the Gaston County community
- Tonight, the Board of Commissioners has the privilege of recognizing the last of four 2010 outstanding individuals as a William Gaston Award Winner: Mr. W. Alex Hall
- At this time, I would ask Mr. Hall to come to the podium along with any family and friends he has with him to receive the William Gaston Award for 2010
- · Commissioner Carpenter will be making the presentation.

### Mr. W. Alex Hall

### Commissioner Carpenter presented:

- Mr. Alex Hall would you please join me at the podium and have wife, Virginia, and anyone who would like to stand in your support to come forward with you
- Alex Hall arrived in Gaston County in 1972 as an employee of the banking industry and since that date has solidly entrenched himself in the workforce and volunteer work of the greater Gaston Community. On January 24, 1985, the County Commission appointed Alex to the Industrial Facilities and Pollution Control Authority and in 1994 he was elected Chairman, a post that he has held since that date. The Authority is charged with the review, approval or denial of industrial revenue bond applications and makes its recommendations to the County Commission. Many new businesses, millions of dollars, and hundreds of jobs have been brought into the Gaston Community as a result of this work. Alex has also been a long time member of the Gaston County Economic Development Commission which recruits and seeks new business ventures to relocate to the County to supply jobs for area citizens. His skills in the financial arena and his knowledge of corporations and how they work have been extremely valuable assets to both of these appointed bodies
- His community outreach and volunteer work is just as outstanding as his work on the Commission's advisory boards and committees.
   Alex has served as President of the Gastonia Rotary Club, Boy Scouts of America Piedmont Council, Gastonia Airport Authority, Hospice of Gaston County, Gaston Chamber of Commerce, Chamber's Economic Development Council, the Carrie E. & Lena V. Glenn Foundation, the Gaston Arts Council, and the Community Foundation
- A friend of his replied that when he thought about Alex two things came to mind: "First, he is dedicated to improving whether it is a
  process or a relationship that he would find a way to make it better; second, that he is a remarkably honest man and one that you will
  always clearly understand his answers to questions and where he stands on issues a trait which has served him well."
- Alex the entire Gaston Community is indebted to you for so generously giving of yourself, your time and your expertise in making Gaston County a better place!
- On behalf of the County Commission, it is my pleasure to present you with the William Gaston Award and to thank you for your immeasurable contributions to our County.

Stating that he felt like a Gaston County native, Mr. Hall related that it had been a great pleasure

Chairman Loftis stated that last year the BOC voted and accepted an offer from the County's accountant to do some procedural checks and balances for volunteer fire departments; County/VFD contracts require an annual audit; when it was rolled into the County's procedures it became more cost effective and VFD accountability was resolved; communications may not have been as clear this year in verifying that the County would set up the process and share funding with the VFDs; some smaller departments may struggle to come up with those funds this late in the budget year; larger VFDs may be okay; would prefer to remove this item from the agenda in order to get feedback from the VFDs and insert it into next year's budget that the VFDs would share in the funding of the audits as an accountability measure to the citizens. The Chairman further suggested that Rescue Squads be included and ordered removal of the item from the Agenda in order to allow issues to be worked out with VFDs and Rescue Squads.

Commissioner Carpenter stated that the BOC taxes citizens in each of the fire districts to pay for expenses of VFDs; many in the County do not live within those districts and pay municipal taxes; would like to see that each district is eventually paying for all services provided.

Commissioner Keigher requested a comparison of the amount paid by city and county residents.

hires including Dr. Jerry Levine from NJ; plan to appoint him to the Health Board; he will work ½ day/week in the Health Department or GFHS to fulfill his public service commitment.

Commissioner Philbeck reported travel to Raleigh along with Commissioner Brown; met with the Speaker of the House, also Senators Forrester and Harrington, Representatives Torbett and Hastings. The 2011 Session was just getting underway; spoke about County issues.

Commissioner Keigher reported attendance, along with Commissioners Loftis and Price, to the Health Board; expressed appreciation for appointees service; to Museum of Art & History Board and related that reconstruction was underway on building front; Blues Out Back will start in May; City of Dallas will block off streets; to DSS 1/27 where food stamps and Medicaid are at an all time high at 20% of the population in both areas.

Commissioner Carpenter reported meeting attendance to the Charlotte Regional Partnership where concerns were expressed about the State budget and how increased enrollment would be affected with less dollars; UNC-C has moved the Entrepreneur Center onto campus; patents developed at the University are used to spin off businesses in the community; private dollars to the Partnership are substantial; reviewed new businesses moving to the Charlotte area; have a lot of projects underway; the global industry is being embraced.

Chairman Loftis reported meeting attendance to the Belmont City Council, along with Commissioners Price and Philbeck, for the purpose of talking about the ETJ and adoption of the UDO; met the next day with Mayor Boyce, Councilman Toole, Commissioner Philbeck, City and County Managers and Planning Staff to discuss Belmont's future growth and how the County could accommodate; a tentative agreement was reached with Belmont that they would adopt the UDO and the County would enforce via an overlay district that will protect their future and orderly growth; Belmont will relinquish the ETJ; Memorandum of Understanding will be forthcoming to BOC.

Chairman Loftis reported traveling to the NACo 2011 Justice and Public Safety Steering Committee Retreat, New Orleans, LA where the agenda consisted of looking at national policy impacting public safety and jails, who gets locked up and at what cost, the possibility of working toward criminal summons rather than lock up; this would allow the district attorney to move through cases faster. The group toured New Orleans wards, burros and the Kings Street Canal and learned that the extensive hurricane damage was caused by a tidal wave that pushed water back into canals resulting in some 3,000 casualties; some counties had not updated Flood Mitigation Plans in 21 years.

Chairman Loftis also reported traveling to Los Angeles on an economic development junket; visited Dole Foods Headquarters; Dole has 800 employees in its Gaston facility; they are looking at expanding by adding an additional line or building another facility. The Chairman related visiting other potential businesses in the area that are interested in the County locations.

Commissioner Price advised that the State was talking about letting counties hold inmates up to 120 days rather than the current 30 days which would reduce prison costs in Raleigh.
