The Gaston County Board of Commissioners (BOC) met in Regular Session on June 23, 2011 at 6:00 pm in the Commissioners Room, Gaston County Courthouse.

Chairman Donnie Loftis presided with Commissioners Tracy L. Philbeck, Vice-Chair; Joe D. Carpenter, Allen R. Fraley, Tom Keigher (arrived at 6:07 pm) and Mickey Price in attendance.

Commissioner Chad Brown was not in attendance.

Others present included Jan Winters, County Manager; Charles L. Moore, County Attorney; and Martha M. Jordan, Clerk to the Board.

Upon request of Chairman Loftis, Commissioner Price led those assembled in the Invocation and Commissioner Fraley led in the Pledge of Allegiance.

In Sympathy - Lance Corporal Nic O'Brien

Chairman Loftis extended grateful appreciation to all who lined the streets from Charlotte-Douglas International Airport's Wilson Hanger to the First Assembly of God Church in Gastonia on June 20 in order to pay tribute to American Hero, Lance Corporal Nic O'Brien of Lucia in Riverbend Township, who was killed on June 9 by a roadside bomb while valiantly and proudly performing his duties as a member of the United States Marines in Afghanistan. On behalf of the entire County, Chairman Loftis extended sincere sympathy and prayers of bereavement for his family as Lance Corporal O'Brien is laid to rest in Arlington National Cemetery, Washington, DC, on June 28, 2011.

NC-Dot Secondary Roads Presentation - Mr. Gary Ray Spangler, District Engineer

Chairman Loftis recognized Mr. Gary Spangler, NC-DOT District Engineer, for presentation of the Secondary Roads Presentation.

Mr. Spangler advised of overseeing roads maintenance for Gaston and Cleveland Counties; introduced Mr. Johnny Murdock, NC-DOT; indicated that the \$1.2M allocation for 2011 was a little less than last year; that dirt roads would be completed in this funding cycle although some may be added at a future date; advised that legislative action would move some funds from secondary construction into resurfacing project funds; that \$39M in anticipated funds would be spent over the six county division this program year; explained that funds come from the old Highway Fund (car sales tax, license tags, etc.) and from the Highway Trust Fund (gas tax passed in 1989); presented the 2011 program as set forth below.

the second.

Responding to Commissioner Carpenter, Mr. Spangler stated that some work would be bid and some accomplished by the NC-DOT crew although not designated as yet; roads would be built at a minimum of 20' unless a dead end which would be 18'; suggested naming SR1377.

Commissioner Philbeck asked for the three roads paved this year; asked if Puett's Chapel Road had been contracted out; advised of cracked driveways; asked for an update on the US321/I-85 surveying.

Mr. Spangler advised that the three were North Lake Wylie, Hamrick and Mountain Island Roads; Puett's Chapel was contracted out via the resurfacing program; citizens need to contact Mr. Murdock for referral to appropriate contractors for any repairs; location surveys were underway for preliminary design of US321/I-85; Mr. Dan Grissom, Division Construction Engineer, would be the contact for that project; not sure the design has been settled yet.

Chairman Loftis asked about the Agenda item regarding abandonment of .15 miles of Mountain Island Road (SR-1933).

Mr. Spangler indicated that the NC-DOT could not get the roadway entirely down to the end of the right-of-way; approached Duke Energy and they agreed with the abandonment and agreed to maintain the .15 section for protection of their facility at the end of the road.

With questions being answered, Chairman Loftis called for the vote, and the BOC unanimously adopted 2011-173 approving the 2011-2012 Secondary Roads Improvement Program as follows:

Commissioner Philbeck thanked citizens for supporting the O'Brien Family and for honoring their son, Lance Corporal Nic O'Brien, as an American Hero.

Commissioner Carpenter reported meeting attendance to NCACC in Asheville along with Chairman Loftis; cited good communications and commissioners support statewide to avoid legislative pass downs to counties during the State Budget process.

Chairman Loftis agreed stating that the NCACC staff had worked hard and that counties received better results this year.

County Manager's Report

Re: Landfill - Currently, three generators fueled by methane gas are running test programs; one generator would come on line providing electricity to Duke Energy next month; a \$2.3M/year gross revenue stream is projected when all three are operating; involves a 10 year debt service payback; maintenance would be approximately \$1M net; net would increase after debt payoff; carbon credits are projected to be about \$500k this year and would be used to fund a water line to serve that area; would also contribute to sewer line installation; development of the Energy Park and road would create jobs, enhance recycling abilities, and extend the useful life of the landfill.

Re: Economic Development Program - In response to a citizen request, staff prepared a report on economic development projects of the past ten years, their impact on citizens in the way of jobs and on the County in the ways of expenditures, incoming revenue and quality of life improvements. The County paid out \$9.5M in grants to new firms, took in \$69.4M in property taxes from new corporate citizens, spent \$16.25M for land acquisitions and infrastructure, \$4.5M for salaries and \$4M in operating costs. This resulted in an overall County profit of \$35M. Along with the expanded tax base, the County gained 3,872 new jobs, new products sold introduced new money into the community, and the spinoff served to multiply the benefits. The Manager indicated that with completion of the Gastonia Technology Park, which included already paid for land and infrastructure, that the County was in the process of announcing new corporate citizens in the very near future.

Commissioner Philbeck requested that the economic development information be posted on the County website.
