Historical Fact—Did You Know?

The U.S. Department of Housing and Urban Development (HUD) is responsible for administering and managing a range of programs authorized and funded by Congress under the basic provisions of the U.S. Housing Act of 1937. The Act created the Public and Indian housing program, which now provides affordable housing to over 1.3 million households nationwide. The aim of the Office of Public and Indian Housing (PIH) is to ensure safe, decent, and affordable housing; create opportunities for residents' self-sufficiency and economic independence; and assure fiscal integrity by all program participants. Local housing agencies were incorporated to manage the housing for low-income residents at rents they could afford.

In December 1938, the Charlotte City Council declared a need for a housing authority in Charlotte. The Council believed that sanitary and safe inhabited dwelling accommodations at rents, which persons of low income could afford, did not exist in the City of Charlotte or its surrounding areas. Mayor Ben E. Douglas appointed a group of five citizens to complete the application for incorporation of the Housing Authority of the City of Charlotte. The North Carolina Secretary of State incorporated the agency in June 1939.

Good things are happening in our community with affordable housing!



affordable, quality housing, and ensuring our impact through this Strawn Master Plan Rendering redevelopment effort is minimal, by incorporating open, green space and including appropriate conditions on this rezoning request", commented Joel Ford, Chairman of the Charlotte Housing Authority Board of Commissioners.

The CHA Master plan anticipates adding up to 800 units. CHA is suggesting an increase in the setbacks adjacent to the single family homes next to the site and increased open, green space.

"Working closely with the neighbors in Dilworth, we have increased the green space and limited the size of buildings allowed. We are considering increased setbacks next to the houses adjacent to the site to include a fifteen foot area that will leave all the existing trees. Our main goal is to maintain our partnership with our neighbors and in turn continue to be a good neighbor," commented Jeff Meadows, CHA Senior Real Estate Development Officer. CHA has suggested six times the required open space as well. The City of Charlotte Planning Department supports the proposed plans.

To help the development blend in with the Dilworth Neighborhood character, height restrictions and design restrictions along Euclid Avenue are included in the plan.

"Our goal is to continue to serve the elderly residents residing at Strawn with updated, quality housing. This type of development increases the financial return to CHA. There is so much need in the community due to the economy and recession that we must continue to look at all avenues of providing housing," remarked Charles Woodyard, Charlotte Housing Authority CEO.

A representative group of community stakeholders in which CHA Real Estate has met with multiple times over the past year include the City of Charlotte Planning Department, CDOT, YMCA, Pritchard Baptist Church, Dilworth Community Development Association, Adjacent Home Owners, Arlington Home Owners Association, and the South End Business Association.

CHA incorporated the feedback of the stakeholders and made revisions to the initial plan.
