Charlotte Housing Authority's Affordable Housing Contribution Moving Forward

The Charlotte Housing Authority (CHA) has 4,335 families on the waiting list for the public housing and housing choice voucher programs, indicating a dire need for affordable housing in the Charlotte community. The Moving To Work (MTW) Demonstration Program (locally known as Moving Forward) has allowed CHA financing flexibility to preserve our existing stock, as well as expand the supply of housing for our low-income families.

Since participating in the Moving Forward Program, CHA has been able to add 493 public housing units, provide subsidies for an additional 509 families not being served through conventional public housing units or housing choice vouchers, and increase its voucher count by 687 through various special programs such as Veteran Affairs Supportive Housing (VASH) and Family Unification Program (FUP).



While the number overall may seem insignificant to some, each home improved the quality of life for a citizen of the Charlotte community. CHA is Creating Community, Empowering Families, and Building Partnerships.

Center For Employment Services First Year Highlights

One of the largest barriers to employment that clients in CHA's portfolio face is lack of job skills or training. According to the 2000 Census, 30.1% of the people living in the West Corridor of Charlotte live below the poverty line. In January 2011, CHA chose a location in West Charlotte to open the Center for Employment Services (CES) to help address these issues. CES is part of CHA's Moving Forward initiative to promote employment and self-reliance in West Charlotte.

budget management. Success at CES is measured the number of clients in training and/or educational programs, the number of clients who secure employment, and increases in client wages.

In its first year, CES had a total of 2,804 customer visits that included repeat visitor counts. 509 were first time visitors. 81% of the visitors were return visitors. These numbers exceeded CES's set goal of 250 visitors in its first year.

During 2011, CES offered a 4-week job readiness

program that 91 visitors successfully completed. 69 graduates gained employment at a 75.8% hiring rate.

A GED program was offered and had 30 program enrollments. Six persons graduate from the GED program in 2011.

local service providers to bring career development opportunities to the area.

CES uses an innovative approach to relationships with partners through cooperation rather than by contract. Partners residing at the center include: Charlotte Works, Jacob's Ladder Job Center West, The Benefit Bank, and City Dive, Inc.

Services offered at CES include help finding a job, completion of GED, basic literary classes, as well as computer training, pre-employment workshops, and

Also in 2011, CES's partner contributions were in excess of \$150,000 and 2,500 volunteers hours were promoted.

As CES enters it second year, the CHA staff looks forward to working with CES partners and volunteers to helping residents move forward in achieving their education, training, and employment goals.

CHA and City Video Collaboration Wins Telly Award



CHA Today, a news segment produced by CHA and the GOV Channel which is under the City of Charlotte's Corporate Communications & Marketing division, has been selected a Bronze winner in the 33rd Annual Telly Awards for its piece titled SHIP (Supportive Housing Innovative Partnership) Initiative. The segment is part of the City's news program *City Source*. With nearly 11,000 entries from all 50 states and numerous countries, this is truly an honor.

The award was given in the TV Programs, Segments, or Promotional Pieces - Social Responsibility category. The segment tells the story of an innovative partnership between The Salvation Army, the Catho-

lic parishes of St. Gabriel and St. Matthew, and the Charlotte Housing Authority to end homelessness for families in the shelter. The initiative provides a stable environment in a community setting with supportive services on site to help the formerly homeless families maintain housing for the long term.
